YCCD Meraki WiFi Information

WPA2-Enterprise Used to Connect to the student and staff WiFi (SSID: YCCD WiFi)

- This uses your current Webadvisor ID and password to access the campus WiFi network
- If you enter your login credentials and select to remember the connection / connect automatically on this device, your login credentials will be stored and should not have to be entered again unless you change devices or your password changes.
- If you travel to any YCCD campus, you will not have to re-enter your credentials to login.


YCCD Acceptable Use Policy


- The Meraki WiFi network will prompt you to accept this policy once every 90 days.

Network SSIDs


- Students and staff, please use the YCCD WiFi network SSID for your network access. The GUEST access speed is much more limited.

YCCD WIFI Terms and Conditions Terms and Conditions

Accordingly, you agree that the owner and/or provider of this network is NOT liable for any interception or transmissions, computer worms or viruses, loss of data, file corruption, backing or damage to your computer or other devices that result from the transmission or download of information or materials through the internet service provided.

Use of the wireless network is subject to the general restrictions outlined below. If abnormal, illegal, or unauthorized behavior is detected, including heavy consumption of bandwidth, the network provider reserves the right to permanently disconnect the offending device from the wireless network.

Examples of Illegal Uses:

The following are representative examples only and do not comprise a comprehensive list of illegal uses:


- High bandwidth operations, such as large file transfers and media sharing with peer-to-peer programs (i.e.torrents)

 6. Facilitating a Violation of these Terms of Use
- 7. Hacking
- 8. Distribution of Internet viruses, Trojan horses, or other destructive activities
- 9. Distributing information regarding the creation of and sending Internet viruses, worms, Trojan horses, pinging, flooding, mail-bombing, or denial of service attacks. HOW TO RECONNECT AND ACCEPT THE ACCEPTABLE USE POLICY

As long as you selected for your device to remember your credentials and to log on automatically, you will not have to re-enter your credentials. You will be required to re-accept the acceptable use policy once every 90 days before being allowed access to the district WiFi network. To re-accept access open your internet browser. If your browser does not open to the acceptable use policy immediately, press your home page icon. If you cannot find your homepage button, close all of your internet browser windows then re-open your browser.
