#### IMPORTANT

ALLOW AT MINIMUM THREE WEEKS AFTER SUBMISSION TO THE FINANCIAL AID OFFICE FOR FILES TO BE COMPLETED AND AWARDED. THE GRANT PAYMENT WILL NOT BE PROCESSED FOR STUDENTS WHO DO NOT HAVE A COMPLETED FINANCIAL AID FILE OR ARE IN A TERMINATED STATUS. STUDENTS IN A TERMINATED STATUS WITH AN EXTENUATING CIRCUMSTANCE CAN SUBMIT A FINANCIAL AID APPEAL. IF YOUR APPEAL IS APPROVED, YOUR PAYMENT WILL BE PROCESSED ON THE NEXT SCHEDULED PAYMENT DATE.

- **PAYMENT AMOUNTS ARE BASED IN THE NUMBER OF ENROLLED UNITS ON THE DATE DISBURSEMENT IS DETERMINED.**
- **UNITS FOR LATE STARTING CLASSES ARE NOT INCLUDED IN THE ENROLLED UNITS UNTIL THE CLASS STARTS.**
- **THE LAST DAY THE FINANCIAL AID OFFICE WILL PROCESS PAYMENT ADJUSTMENTS IS 7/10.**
- **CLASSES THAT START/STUDENTS ENROLL IN AFTER 7/5 ARE NOT ACCEPTED FOR FINANCIAL AID**
- **STUDENTS WHO DROP ALL CLASSES ON OR AFTER 7/10 WILL NOT BE REQUIRED TO REPAY PELL-GRANT FUNDS**
- **FINANCIAL AID PAYMENT DATES MAY CHANGE DUE TO AVAILABILITY OF FUNDING - IF THIS OCCURS, A REVISED PAYMENT SCHEDULE WILL BE MADE AVAILABLE.**
- **ELIGIBLE STUDENTS WHO FILE EARLY, AND VERIFY THEIR FINANCIAL AID FILE IS COMPLETE, CAN RECEIVE THEIR FINANCIAL AID AND DISBURSEMENTS SHORTLY AFTER THE SEMESTER BEGINS**
- **FINANCIAL AID IS DISBURSED WITH BM TECHNOLOGIES, INC./ FIRST CAROLINA BANK.**
